This is an existing location built by the previous operator prior to the Form 2A requirement. Form 2A is being submitted for additional wells being planned from this location, however there is no additional surface disturbance proposed at this time. There is currently 1 producing well on this pad along with 1 injection well (please refer to facilities layout for additional detail).

Pre-application notifications were not required as all surface owners within 1000' are Ursa or Federal and there are no building units located within 1000' of the pad location. Ursa will be pursuing Federal APDs for the proposed Boies Ranch B-19N wells concurrently with this application.
