While running the production liner, before landing on bottom, our 4.5" production casing parted 13 joints below the liner hanger. BBC attempted to fish the casing string several times but were ultimately unsuccessful. With the fish top inside of 7" casing, we are unable to perform a sidetrack and have decided to P&A the original hole and redrill the well.  
BBC request an increase from the number of well on location from 6 to 7 wells.
