Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 7113'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6788'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with casing cutter. Cut 4 1/2" casing at 750'. Pull cut casing.
6. TIH with tubing to 800'. RU cementing company. Mix and pump 380 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.

If there is bradenhead pressure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 7113'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6788'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with casing cutter. Cut 4 1/2" casing at 1500'. Pull cut casing.
6. TIH with tubing to 1550'. RU cementing company. Mix and pump 75 sxs 15.8#/gal CI G cement down tubing. Wait 8 hours or overnight. Check to see if there is any bradenhead pressure or fluid flow after stub plug is set. If there is, contact COGCC for further guidance. If there is not, move on to step 7.
7. TIH with tubing to 750'. RU cementing company. Mix and pump 525 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
8. Cut surface casing 6' below ground level and weld on cap.
