Comments:

Wexpro Company reseeded the approximate 0.2 acres of the final reclamation of the F Wilson 5 well pad, due to insufficient vegetation for Final Abandonment requirements. Seeding was completed in the Fall of 2017 by Powell Restoration. The location was drill seeded with crimped straw mulch and amendments were applied to increase chances of success. Triganics was applied at a rate of 3500 lb/acre and 3-6-3 at a rate of 50 lbs/acre. The seed supplier could not provide Shadscale, so Fourwing Saltbush was substituted. Please see the attached seed tags and amendment information.
