#### OPERATOR COMMENT AND SUBMITTAL

Comment: Corrective action completed on 11/20/2017. Site was fenced to prevent cattle from damaging reclaimed area. Site was then deep cross ripped, drill seeded with sandy soil/native prairie mix, and straw mulched/crimped with certified seed free straw. The site will be inspected in Spring 2018 for necessary weed control and treated as necessary.  
Note - Site was originally prepped, seeded, and mulched in June 2017. However, the tenant for the surface placed his salt blocks at the site and his cattle ruined the reclamation effort. For this reason, it was necessary to fence the site.
