
Dear Director Lepore:

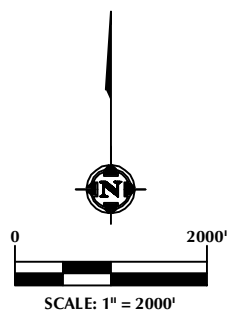
