Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 10/27/2014. Does not appear the Operator has removed gravel from the battery location; therefore, Operator has not performed compaction alleviation which is evident due to the lack of growth that is not reflective of reference vegetative levels. Appears subsidence is evident at the well location. Does not appear the Operator has contoured the access road used for the well location.

Corrective Action:

Perform reclamation in accordance to Rule 1004. Reclamation activities shall be complete no later than 3/30/2018. See COGCC comments for additional compliance information.

Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner or a seed mixture provided by the local county Natural Resources Conservation Service. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed pursuant to Rule 1004 standards.
