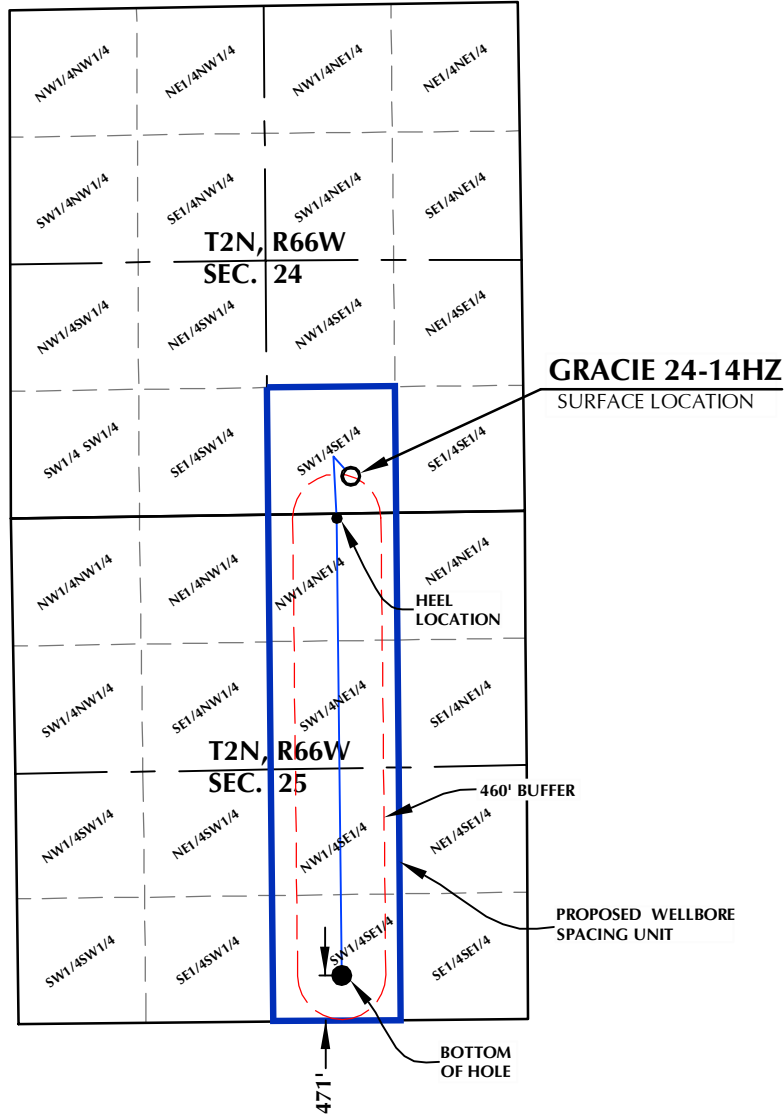

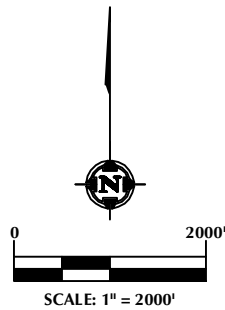
DISTANCE FROM COMPLETED
