Top of cement was found at surface per the attached CBL. PDC requests approval for Option 4 remediation on this well in lieu of option 1 or 2 as required by COA for the McGlothlin Farms permits (API #123-44004). We pulled tubing, installed a CIBP, installed a 5K wellhead, pressure tested to 1500 psi and will setup automation and monitor the bradenhead until the aforementioned pad has been completed.
