## OPERATOR COMMENTS AND SUBMITTAL

Comments As PetroShare has purchased this location from PDC, we have changed the casing and cementing program, waste disposal, distance to nearby wells and offset well evaluation from the original permit. This location has not been built.

Distance from completed portion of the wellbore to nearest wellbore permitted or completed in the same formation was measured to the Sack 12-6. This measurement was taken from the Anti-Collision report.

Distance to nearest permitted or existing wellbore belonging to another operator was measured to the producing Sack State 30C-30HZ owned by Kerr McGee Oil and Gas.

The Corcilus 6E-223 will have a treated interval less than 150' from the treated interval of the Bredehoft 13-6, Sack 11-6 and Sack 12-6. All wells are owned by PetroShare. so no stimulation setback consent is needed.

1	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
2	Drilling/Completion Operations	Anti-Collision: PetroShare will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice will be given to all offset operators within 150 feet prior to drilling.
