SE¼SE¼ of Section 29, Township 7 North, Range 66 West  
N½N½ of Section 33 & 34, Township 7 North, Range 66 West  
NE¼NE¼ of Section 32, Township 7 North, Range 66 West  
Containing 720.00 acres, more or less

Bayswater is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(6). Copies of the required notification letters are on file at Bayswater's office. The required thirty (30) day notice period has elapsed absent the receipt by Bayswater of any objection to their proposal by the owners within the Proposed Spacing Unit for the subject well.

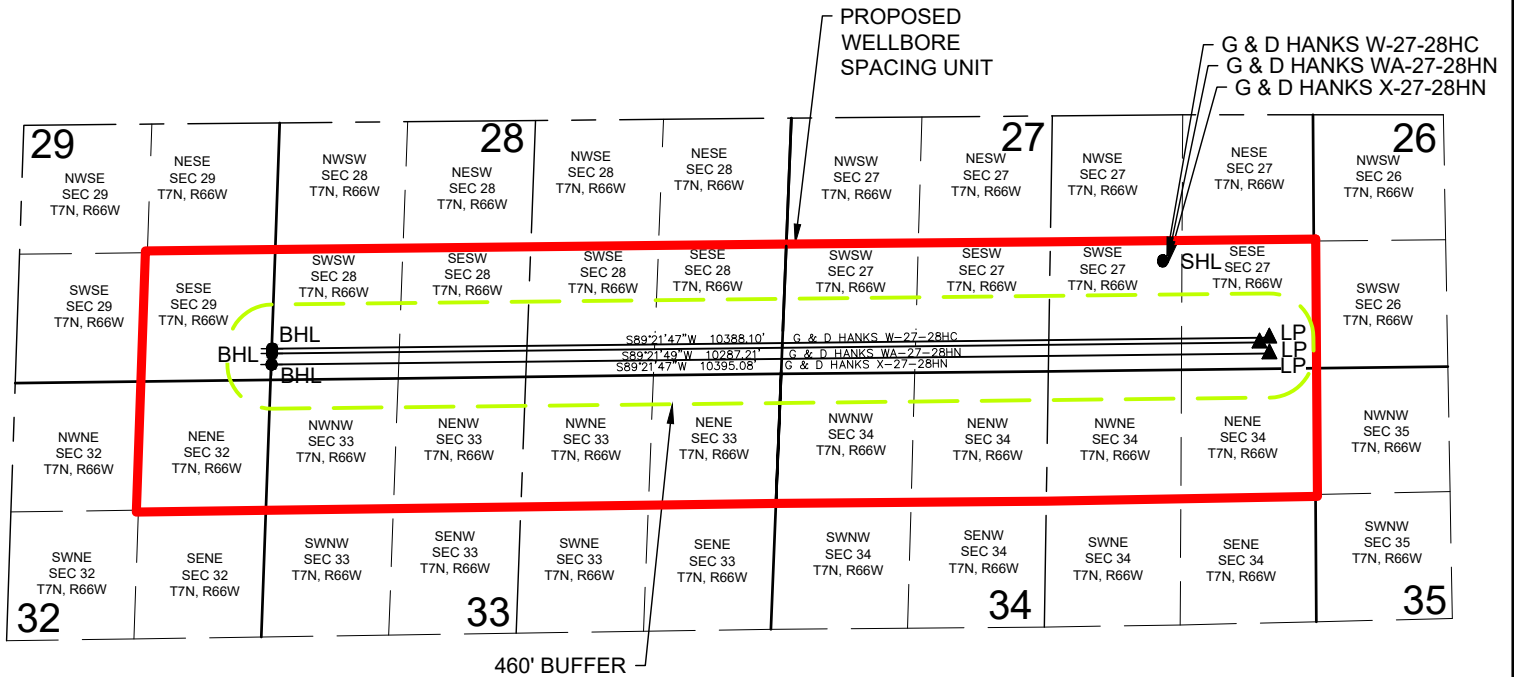

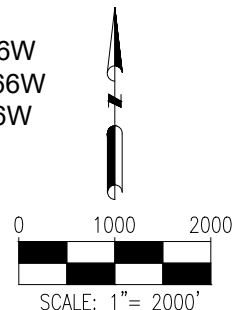


**G & D HANKS W-27-28HC WELL TO BE LOCATED 1153' FSL AND 1575' FEL, SEC 27, T7N, R66W**
