Regarding the e-mail correspondence with Black Hills on May 8, 2017, Action Item #2 regarding Spill# 2221287.

In 2011, upon removal of the tank in that was present within the small pit (~10'x10'x8'), a sample was collected from the pit bottom to a depth of 12" below ground surface (bgs) and submitted to ALS for COGCC Table 910-1 thresholds. Soil did not contain any concentrations exceeding Table 910-1 standards and no remediation was necessary. No material was excavated or treated on-site, as there was no need due to results satisfy COGCC Table 910-1.

Form 19 submitted July 30, 2011 (Spill# 2221287) includes confirmation analytical showing soils satisfy COGCC Table 910-1, along with sample location map.

Confirmation data (ALS Lab Report # 1105413) is also attached to this Form 4 for reference.
