Noble Energy requests the removal of the Wells Trust 24-21 well, API No. 05-123-20034, Operator: PDC, from the COGCC Conditions of Approval noted on the subject APD. There is currently a cast iron bridge plug with 2 sacks of cement 50' above the perfs of the Wells Trust 24-21 well. On 3/9/17 PDC also pressure tested the casing of this well and it had integrity; there is also a 5k wellhead. PDC plans to P&A the Wells Trust 24-21 post frac and bradenhead monitor the well during the frac. The COGCC has been notified of the situation and is amenable to PDC's proposed plans.
