<p>Comment: COGCC has approved an extension to long-term stabilization on the well pad cut-slope to May 30, 2018, with the condition of approval that temporary stormwater controls be installed. These have not been installed. Maintenance along the access road has occurred, clearing sediment out of culverts and roadside ditches. However, sediment was placed on hillside where it is smothering vegetation, is exposed, and will rapidly erode. This is not an effective sediment management practice.</p> <p>Corrective Action: Corrective action to install stabilization measures on well pad cut-slopes by November 30, 2017 is not addressed. Sediment piles on slopes along the access road and above culverts need to be removed and properly disposed of. If vegetation is damaged, then re-seeding is required. Corrective action date will remain to document time since original corrective action date.</p> <p>Date: 11/30/2017</p>
