 This is a reclamation and stormwater inspection for spill or release 451533. As indicated during the October 2017 inspection, straw blanket and likely seeding is conducted in fenced area near riser. Exposed soils leading from road up to riser are roughened and appear to be seeded. This area needs careful monitoring to ensure soil does not begin eroding during snowmelt and rain events.
