Land has been recently tilled. Even if the surface owner wants to perform the work themselves, the Operator is still held responsible to ensure the location meets Rule 1004 standards. It appears the access road may not have been recontoured as soil material appeared to be elevated along the access road in relation to the adjacent land; therefore, the corrective action date on this inspection remain the same from the previous inspection.
