Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
 2. RU wireline company.
 3. TIH with CIBP. Set BP at 6760'. Top with 2 sxs 15.8#/gal CI G cement.
 4. TIH with CIBP. Set BP at 6470'. Top with 2 sxs 15.8#/gal CI G cement.
 5. TIH with casing cutter. Cut 4 1/2" casing at 1100'. Pull cut casing.
 6. TIH with tubing to 1150'. RU cementing company. Mix and pump 490 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
 7. Cut surface casing 6' below ground level and weld on cap.
- If there is bradenhead pressure:
1. MIRU pulling unit. Pull 2 3/8" tubing.
 2. RU wireline company.
 3. TIH with CIBP. Set BP at 6760'. Top with 2 sxs 15.8#/gal CI G cement.
 4. TIH with CIBP. Set BP at 6470'. Top with 2 sxs 15.8#/gal CI G cement.
 5. TIH with casing cutter. Cut 4 1/2" casing at 1400'. Pull cut casing.
 6. TIH with tubing to 1450'. RU cementing company. Mix and pump 75 sxs 15.8#/gal CI G cement down tubing. Wait 8 hours or overnight. Check to see if there is any bradenhead pressure or fluid flow after stub plug is set. If there is, contact COGCC for further guidance. If there is not, move on to the next step.
 7. TIH with tubing to 1100'. RU cementing company. Mix and pump 800 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
 8. Cut surface casing 6' below ground level and weld on cap.

If evidence of fluid migration or pressure remains, contact COGCC Engineer for an update to plugging requirements.</p> <p>3) After isolation has been verified, pump plug and displace. If cement is not circulated to surface, shut-in, WOC 4 hours and tag plug – top of plug must be not deeper than 838' and provide minimum 10 sx plug at the surface. Leave at least 100' of cement in the wellbore for each plug.</p> <p>4) Properly abandon all flowlines. Once flowlines are properly abandoned, file electronic form 42.</p>
	<p>Prior to starting plugging operations a bradenhead test shall be performed.</p> <p>1)If, before opening the bradenhead valve, the beginning pressure is greater than 25 psi, sampling is required.</p> <p>2)If pressure remains at the conclusion of the test, or if any liquids were present during the test, sampling is required.</p> <p>3)If sampling is required contact COGCC engineering for a confirmation of plugging requirements prior to placing any plugs.</p> <p>4)Sampling shall comply with Operator Guidance - Bradenhead Testing and Reporting Instructions.
