 Field Inspector Actions:
 On 12-18-2017, I was contacted by complaint specialist Megan Adamczyk in reference to a complaint received for noise on 12-17-2017 by the COGCC about odors occurring in the Erie area west of the Anadarko, Papa Jo location. I contacted the complainant who indicated he had a strong odor at his residence which he believed was coming from the Anadarko drilling location which was located to the east of his home. The complaint questioned if Anadarko was utilizing a mud chiller on location.
 On 12-19-2017 at approx 0730 hrs I performed a complete site inspection of the Papa Jo location and the neighborhoods around the location. At the time of inspection, I observed the Extreme Rig 24 drilling rig performing normal drilling operation on location. I contacted Sean from Anadarko who indicated the rig had been performing normal drilling activity at the time of the complaint. At the time of the inspection of the drilling rig Sean indicated Anadarko was continuing to use an odor neutralizer to mitigate odors at the drilling rig at the time of the complaint. At the time of the inspection all lighting on location appeared to be pointed toward the ground and center of location. I reviewed location records, which did not show any abnormal drilling operations at the time of the complaints.
 I also performed a site inspection of the precision rig conducting drilling operations to the east of the Extreme rig at the Papa Jo location east.
 As part of the inspection prior to the rig inspection I checked the area of the complaints residence for odors and at the time of the inspection I did not detect any odors off location during my investigation.
 All information reviewed and site inspection information were submitted to the COGCC for further review.
 No violations of COGCC rules were observed at the time of the inspection
