COMMENTS:

The well was originally shut-in for a Horizontal Safety Prep. RBP W/SAND CAP at 6830' and RBP W/SAND CAP at 4400'. A RBP pressure test was conducted after each plug was set to ensure integrity of the casing on 03/10/2017 and 3/11/2017, to 1000 lbs for 15 min and were good tests. The well will continue to be shut-in until the well is plugged and abandoned by the end of 2018. T&A status provided via a down-hole plug and surface isolation provided by a closed master valve.
