Activity update follows for this site, which is subject to 2017 Administrative Order by Consent No. 1V-638 and earlier Rule 502 variance dated July 19, 2011. During the current year, Petroglyph Operating Company Inc.'s environmental contractor performed weed treatment, vegetation monitoring and erosion control during the periods of May, July, October and December.

- 1) On May 23, 2017 during field-wide weed treatment, there were no noxious weed present.
- 2) On July 25, 2017, monitoring was performed on site, with photos attached.
- 3) On October 13, 2017, the following were observed and treated: B-List (None), C-List (cheatgrass).
- 4) During the period from December 4 through 12, 2017, the contractor inspected the site for erosion control and constructed loose-rock check dams, as depicted on the attached photographs.
