SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

This well completed in November 1953. Well has been shut in since September 1957 as well had watered out. It is proposed to plug and abandon this well by filling hole with heavy mud between cement plugs as follows: A rock and cement bridge above perforations, cement plug in bottom of surface casing and a cement plug in top of surface casing. The casing will be shot off above cement and pulled leaving the remainder in hole. The 200 feet of surface casing will be left in hole. A dry hole marker will be erected and the location cleaned up and graded before abandoning.
