Inspection #675103780 documented Canada thistle on the south end of the location. This is a Colorado State listed noxious weed and was required to be managed. Canada thistle remains on location and does not appear to have been managed per the corrective action; Operator has failed to manage weeds in a timely manner. Photo 2 in the attached photo document shows that Canada thistle was not removed per corrective actions in 2017, was allowed to reach maturity and seed-out. Canada thistle has possibly spread throughout location and adjacent lands. This may be referred to enforcement.
