Per Rule 317.p Exception, compensated neutron logs have been run on the Wagner 27C-10HZ Well (API: 05-123-43474).  
The Top of Productive Zone provided is an estimate based on the landing point at 8176' MD.  
As-drilled GPS data was taken after conductor was set.  
Completion is estimated for Q2 2018.
