1	Planning	Wellbore Collision Prevention- Rule 317.r Prior to drilling operations, Bonanza Creek will perform an anti-collision scan of existing offset wells that have the potential of being within close proximity of the proposed well. This anti-collision scan will include definitive MWD or gyro surveys of the offset wells with included error of uncertainty per survey instrument, and compared against the proposed well path with its respective error of uncertainty. If current surveys do not exist for the offset wells, Operator may have gyro surveys conducted to verify bottom hole location. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision or harm to people or the environment.
2	Drilling/Completion Operations	Open-Hole Logging – Rule 317.p This well will be logged with open-hole Resistivity and Gamma Ray Log from the kickoff point into the surface casing. A cement bond log with gamma-ray run on production casing (intermediate casing or production liner if run) into the surface casing. The horizontal portion of the well will be logging with a measure-while-drilling gamma-ray log. The Form 5, Completion Report, for the well will list all logs run and have those logs attached.
