Use Option 4 for the COA on the Haake Farms well, 05-001-06980, based on approval after the CBL on the Haake Farms (05-001-06980) to verify that cement was placed behind pipe. The log was submitted with doc. 401503568.

The base of cement at surface is at 960', the base of the Fox Hills is at 920' and there is an offset water well drilled to 1020'.

There is good coverage over the following:

Niobrara - top 7210' Cement to 6962'

Shannon - top 5200' Cement covering from 5220' to 4820'

Sussex - top 4680' cement coverage from 4482' to 3800'

With good Isolation on the annulus and we will set a bridge plug around 7150' isolating the Niobrara inside casing.
