Performed bradenhead test on 10 well pad post production. Initial bradenhead pressure 475 psi blew down to 0 psi after 1 minute. PDC is requesting a blowdown period and will plumb the bradenhead to a tank for 7 days monitor and re-test. A Bradenhead gas sample will be collected and submitted to COGCC as soon as results are available.
