

 12/22/52 Drill stem test No. 1 4858-64 Open 1 hr. Recovered 730 feet water with rainbow show of oil, trace of gas. IFPO. FFP 325. SI 30 min 1160.
 Hydr 2750. Ran Schlumberger. Prepare to plug and abandon. A cement plug was spotted from 4864 feet (total depth) to 4850 feet opposite the 'Muddy' sandstone. Heavy mud taken from the pit was then placed from 4850 feet to 625 feet (15 feet below bottom of surface casing). A cement plug was then spotted to 595 feet with heavy mud being placed to 15 feet. A cement plug being spotted from 15 feet to the surface in such a manner as not to interfere with surface cultivation. Plug and Abandon. Complete.
