**COMMENTS:**

Vanguard respectfully requests approval to temporarily utilize the Jolley 20-6-66S91W/20SESE location (COGCC Location ID #335185) to store (3) 500 barrel frac tanks which will be utilized in association with the TEP/Vanguard water share agreement. This location is adjacent to the TEP facility and the custody transfer point. The tanks will be stored within a lined secondary containment and will comply with our existing SPCC Plan. The tanks will be continuously monitored by field personnel during all transfer operations. Details regarding the construction layout, tanks and the dimensions of the secondary containments are included in the attachments.

The tanks are expected to remain on the Jolley 20-6-66S91W/20SESE location until December 31, 2018 which is the timeframe proposed in the water sharing agreement. This time frame is needed due to the phased completion and flowback schedules associated with the new wells at the GGU 13-28 (Location ID 335245) and MDP-25 (SESW 33-691) (Location ID 424341) locations. The current schedule has completion activities continuing through August, but extending this timing until the end of 2018 allows for some operational flexibility, if needed.

Vanguard will also be installing several temporary 10" surface poly lines at the location to convey the water from the custody transfer point to the three tanks and also from the tanks to Vanguard pipeline riser. These details are provided on the attached diagram.
