Request Option 4 for the COA on the Guthrie Abner 1 well, API 05-001-06251, operated by PetroShare. A RBP was set @ 7584', CBL run from 7568' to surface (and submitted by PetroShare) shows adequate isolation of the Niobrara. The aquifer coverage is a little short (50'), but has been approved for Option 4 and the operator will monitor during the stimulation of all of the Marcus wells stimulation. Should there be any communication with this well, the stimulation will be stopped immediately and the well addressed.
