Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
 2. RU wireline company.
 3. TIH with CIBP. Set BP at 6545'. Top with 2 sxs 15.8#/gal CI G cement.
 4. TIH with casing cutter. Cut 4 1/2" casing at 650'. Pull cut casing.
 5. TIH with tubing to 700'. RU cementing company. Mix and pump 355 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
 6. Cut surface casing 6' below ground level and weld on cap.
- If there is bradenhead pressure:
1. MIRU pulling unit. Pull 2 3/8" tubing.
 2. RU wireline company.
 3. TIH with CIBP. Set BP at 6545'. Top with 2 sxs 15.8#/gal CI G cement.
 4. TIH with casing cutter. Cut 4 1/2" casing at 1500'. Pull cut casing.
 5. TIH with tubing to 1550'. RU cementing company. Mix and pump 75 sxs 15.8#/gal CI G cement down tubing. Wait 8 hours or overnight. Check to see if there is any bradenhead pressure or fluid flow after stub plug is set. If there is, contact COGCC for further guidance. If there is not, move on to step 6.
 6. TIH with tubing to 650'. RU cementing company. Mix and pump 450 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
 7. Cut surface casing 6' below ground level and weld on cap.
