Comment: Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 6/20/2014. The well location appears to meet Rule 1004 standards; however, the battery location does not meet reclamation requirements. Appears gravel has not been removed throughout the location and weedy, annual vegetation was observed as well as a List C CO Noxious weed, Puncture vine. Please refer to the attached inspection photos for more details.

Corrective Action:	Since the spring seeding window has passed, revegetation activities shall be complete no later than 11/15/17. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.	Date	11/15/2017
