Kris,

I did some digging for you. To start we have no records for that location prior to 2006. I did check Google Earth and the pit is visible in the 1999 aerial photo. The pit appears to be a produced water pit. It is immediately east of the current heater treater (see below). I spoke with Bill (our field foreman) and he indicated that the pit was removed by Nielsen prior to our ownership. The pit was backfilled and a water leg was installed that now dumps to a produced water tank at the on-pad tank battery. The former pit would be located beneath our current access around the heater treater.
