#### COMMENTS:

Due to adverse wellbore conditions Caerus Piceance LLC is setting surface casing shallow at 1,365 ft MD. The Wasatch in this well was prog'd at 1,666 ft MD. This places surface casing ~300 ft above the base of the Green River according to pre-drill prog. According to the Colorado Ground-Water Atlas, the base of the Green River formation is the Anvil Points member which is 1,870 ft thick. This means that our surface casing is well within the Anvil Points member. The Anvil Points is not listed as an aquifer in the atlas. Seeing as our surface casing is well within this member, we should have no risk of oil and gas migrating into shallower potential aquifers.
