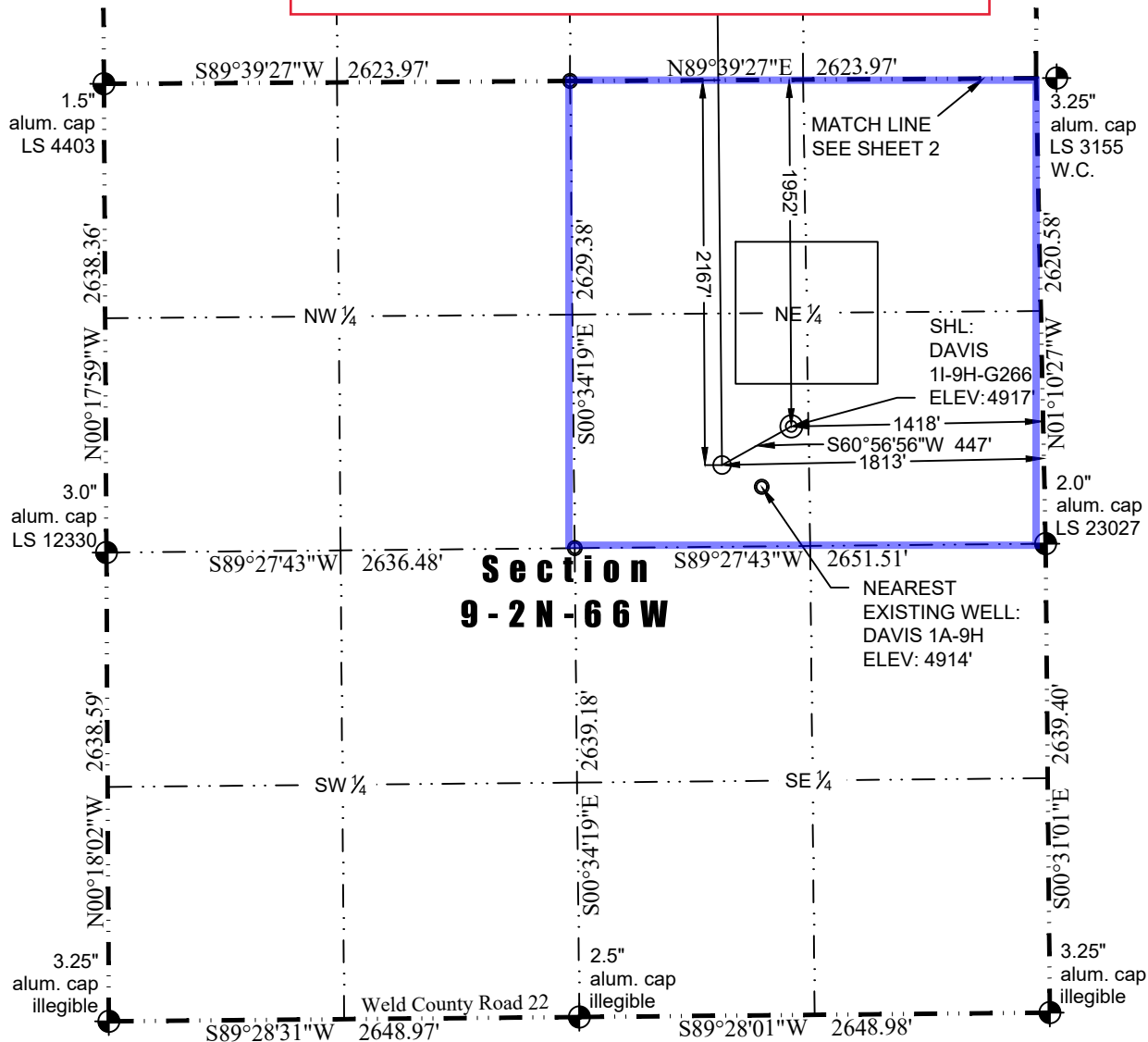
Attached is a copy of the map illustrating the proposed wellbore spacing unit to assist you in your review and approval of CPR's proposed APD for the captioned well.

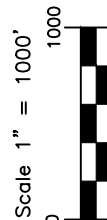
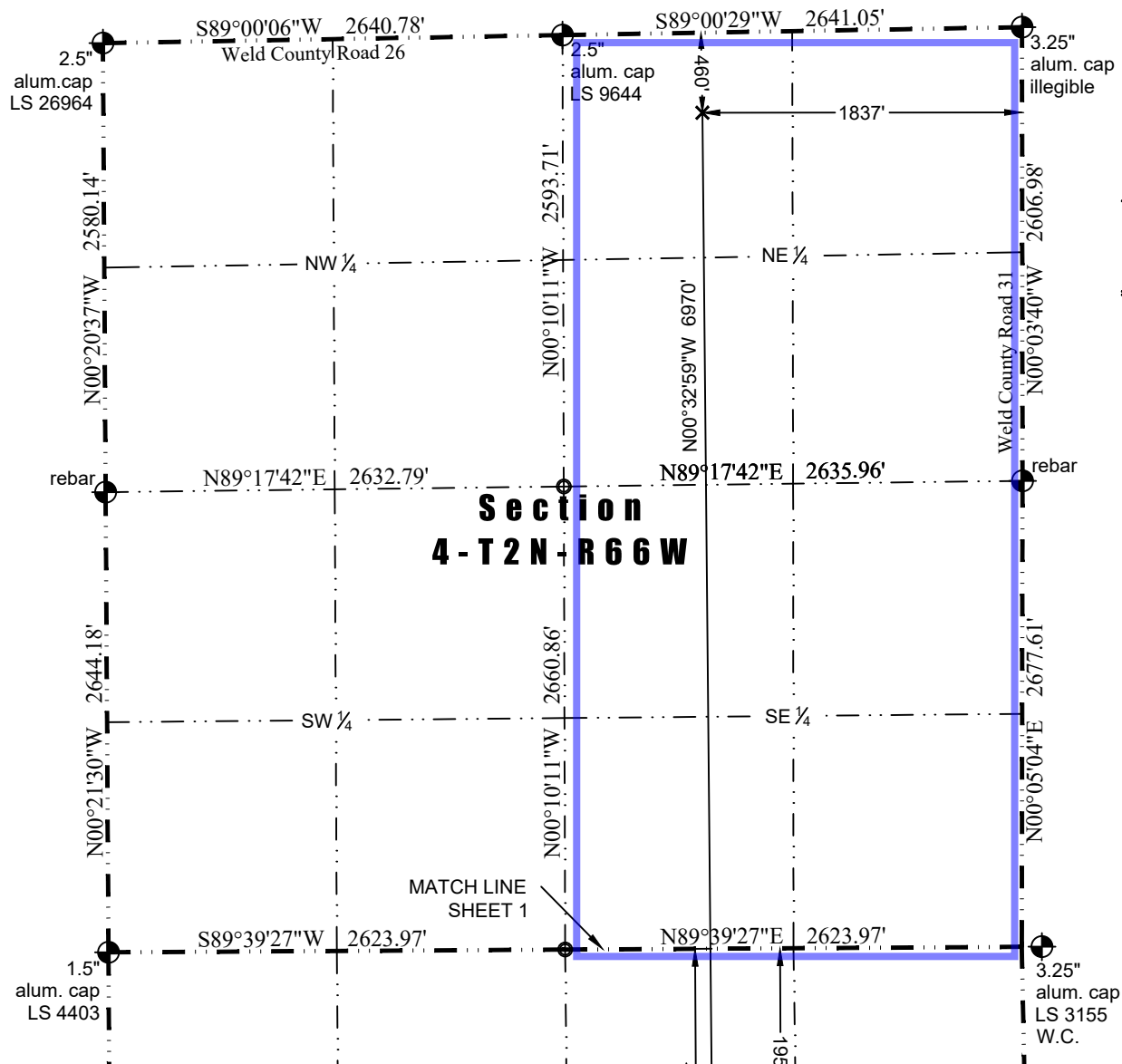
