**General Comment:**

This Inspection was originally submitted 1/12/18. Operator of Record has indicated that Location ownership was transferred in 2013 to other Operator. Inspection is now being submitted with other Operator as Contact; this Operator should contact Inspector if they are not responsible for this Location.

This is an Abandoned Location Inspection, for Six Wells, listed in Inspected Facilities, above; a Follow Up to Insp Doc#668500179, Dated 10/9/2012. The APDs were First Approved in 2007; Permits Abandoned in 20011 with Boxes checked that Yes, Location was Built & Yes, Site was Ready for Inspection at Date 10/7/11.

Previous Insp Failed Final Reclamation with a CA to "Submit a Final Reclamation Plan to COGCC & initiate final reclamation activities per 1004 Series rules"; CA Date of 12/14/12. CAs remain unresolved. Though Snow Cover prevented Access to Location; site was viewed from Ridge to North & Point of Access Rd divergence from Main Rd; these views show that Location & Access Rd have not been Reclaimed (Refer to Photos Attached). Google Earth 2016 Images also show Location, Not Reclaimed.

Location has been Out of Compliance for More than Five Years. Following discussion with Staff this Inspection may be referred to Enforcement.
