At the time of the inspection I observed normal production operations occurring on location. I observed staff replacing a compressor on location, they indicated they were replacing the compressor due to failure of the other unit which caused upset conditions during the time of the complaints complaint. Due to high winds in the area I was unable to perform a sound study at the time of the inspection.</p> <p>All information reviewed and site inspection information were submitted to the COGCC for further review.</p> <p>I did not observe any violations of COGCC rules at the time of the inspection.</p>
