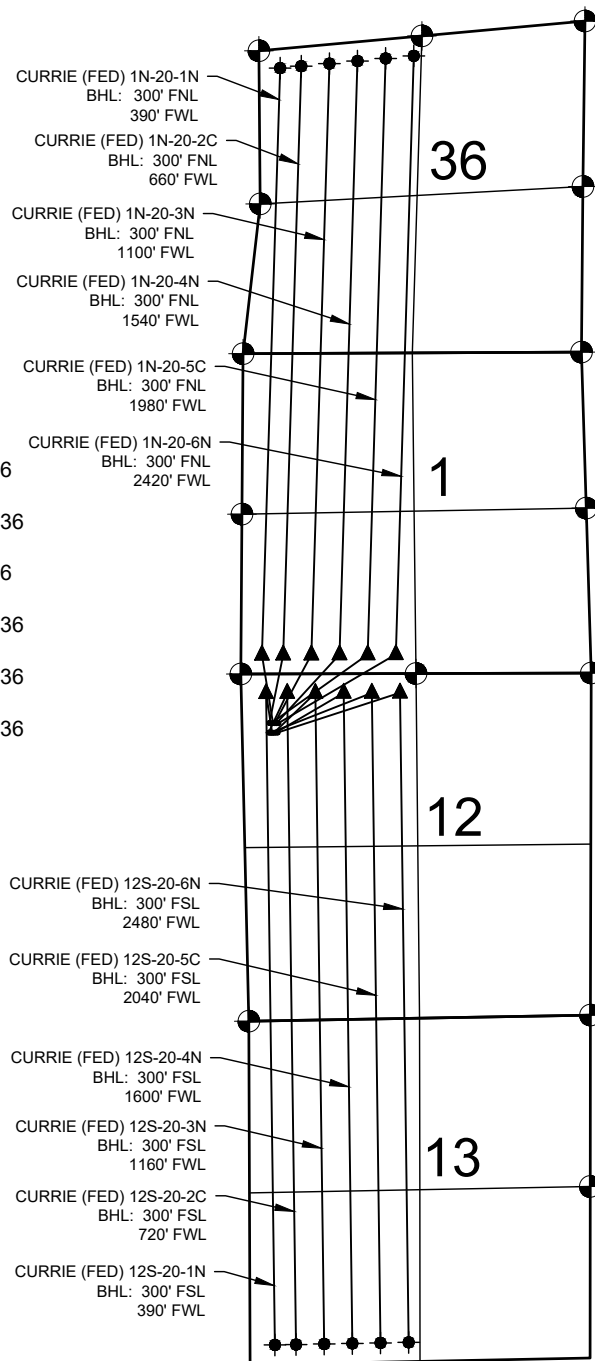


CURRIE (FED) 12-A PAD MULTI-WELL PLAN

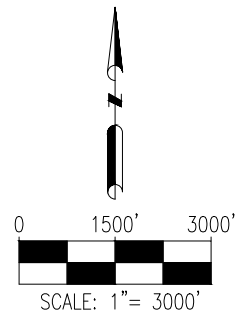
