I'd like to request to remove the COA of this well and all other wells attached to the Coyote Trails facility (319094) requiring the remediation of the Asher 1 (05-014-05579) per the DJ Basin Horizontal Offset policy (option 3) .

The Asher 1 (05-014-05579) was drilled and abandoned in 1951 (I've attached an as-plugged WBD I've generated as well). Its re-entry is listed as a COA as not having adequate cement coverage to isolate the aquifer, however the well's TD is at 5625'. Since all the Coyote Trails wells will be either Nios or Codells, stimulation will occur at least 2000' below the Asher's TD.
