Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
 2. RU wireline company.
 3. TIH with CIBP. Set BP at 7138'. Top with 2 sxs 15.8#/gal CI G cement.
 4. TIH with CIBP. Set BP at 6832'. Top with 2 sxs 15.8#/gal CI G cement.
 5. TIH with casing cutter. Cut 4 1/2" casing at 750'. Pull cut casing.
 6. TIH with tubing to 800'. RU cementing company. Mix and pump 365 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
 7. Cut surface casing 6' below ground level and weld on cap.
- If there is bradenhead pressure:
1. MIRU pulling unit. Pull 2 3/8" tubing.
 2. RU wireline company.
 3. TIH with CIBP. Set BP at 7138'. Top with 2 sxs 15.8#/gal CI G cement.
 4. TIH with CIBP. Set BP at 6832'. Top with 2 sxs 15.8#/gal CI G cement.
 5. TIH with casing cutter. Cut 4 1/2" casing at 1500'. Pull cut casing.
 6. TIH with tubing to 1550'. RU cementing company. Mix and pump 75 sxs 15.8#/gal CI G cement down tubing. Wait 8 hours or overnight. Check to see if there is any bradenhead pressure or fluid flow after stub plug is set. If there is, contact COGCC for further guidance. If there is not, move on to step 7.
 7. TIH with tubing to 700'. RU cementing company. Mix and pump 500 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
 8. Cut surface casing 6' below ground level and weld on cap.

The Form 17 shall be submitted within 10 days of the test.</p>
	<p>1)Submit Form 42 electronically to COGCC 48 hours prior to MIRU electronically to COGCC 48 hours prior to MIRU.</p> <p>2)Prior to placing the 800' plug: verify that all fluid migration (liquid or gas) has been eliminated. If evidence of fluid migration or pressure remains, contact COGCC Engineer for an update to plugging requirements. .</p> <p>3)After isolation has been verified, pump plug and displace. If cement is not circulated to surface, shut-in, WOC 4 hours and tag plug – top of plug must be not deeper than 497' and provide minimum 10 sx plug at the surface.
