Comments

This location is being amended for the purpose of reusing the existing location ID#. All previously permitted wells associated with the pad have expired and are not to be included in the new location. All previously permitted footages and location specific information is to be void and updated with the details outlined in this 2A. The location identification footages were provided from the Critter Creek 210-1411H proposed well. The distances for the cultural setbacks were provided from the nearest proposed well on the pad. All salable quality gas will be piped to a sales line. No unnecessary or excessive flaring will occur at the subject location. Per rule 316C.c a 48 hour notice will be filed prior to commencement of construction operations with the COGCC via a Form 42. The approved spacing order for each proposed Codell well on the pad is 421-79. The approved spacing order for each proposed Niobrara well on the pad is 421-94. The nearest water well was determined using the COGCC maps and the CDWR permit database. The water well is located NE of the subject location and is not permitted with the CDWR. The depth to ground water was determined by permit number 145577 with 26' to ground water. Surface Use Agreement attached for informational purposes.
