SG is requesting to temporarily remove all production equipment on the existing Federal 11-90-26 #1 well pad location to accommodate a drill rig for re-entering the existing well bore this spring, 2018. Per concurrence with SG and the BLM, the equipment would be temporarily sotred at the near-by McIntyre Pit #3 and #4 Facility. Equipment would be stored in an orderly and safe manner as to allow continued operations at the McIntyre Facility. Upon well completion, SG would prepare the well pad location for replacement of equipment. SG anticipates equipment replacement would take approximately 30 days upon well completion.
