## COMMENTS:

TEP Rocky Mountain LLC (TEP) respectfully requests approval to upgrade the existing tank battery at the Golding 4 Pad (Loc ID #335688) to support produced water storage from new wells planned on the NR 23-3 Pad (Loc ID #422211).

The seven existing tanks (4-Water/3-Condensate) will be expanded and replaced with ten (10) new tanks (6-500 bbl water/4-300 bbl condensate) within a 92' x 44' lined steel containment structure. The existing four-inch water pipeline will be abandoned or removed, and replaced with a new four-inch flexpipe water pipeline from the Clough 18 pad to the Golding 4 Pad. This four-inch water pipeline will be utilized to transport produced water from the NR 23-3 pad to the Golding 4 Pad. One additional ECD will be placed on location adjacent to the separators for a total of two ECDs. See attached Plan of Development for the Golding 4 pad for further details.
