Comment

Portions of the northern and western interim do not meet Rule 1003 standards, as weedy, annual vegetation (Kochia) dominates the area. It appears portions of the northeastern and eastern interim areas would meet Rule 1003 standards. Refer to the attached inspection photos for more detail.

Corrective Action

Perform reclamation in accordance with Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture with species consistent with the adjacent plant community or a seed mixture requested by the surface owner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards. Interim reclamation activities shall be complete no later than April 30, 2018.
