The Storage Area is needed for Laramie's planned drilling in the area. Use of the storage area will minimize surface disturbances in other portions of the upper Cascade Creek region (also known as the Roan Plateau). An Interim Reclamation Variance Request has been submitted for the Storage and Laydown portion of the location. As noted in the most recent inspection, Laramie has performed interim reclaim

on the original drill pad location. This Storage and Laydown location is situated apart from the original 335889 drill pad. This location was permitted according to the Garfield County Land Use Code as a Storage Facility and will continue to be used as such.
