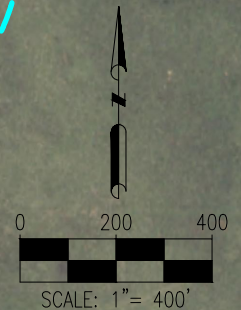
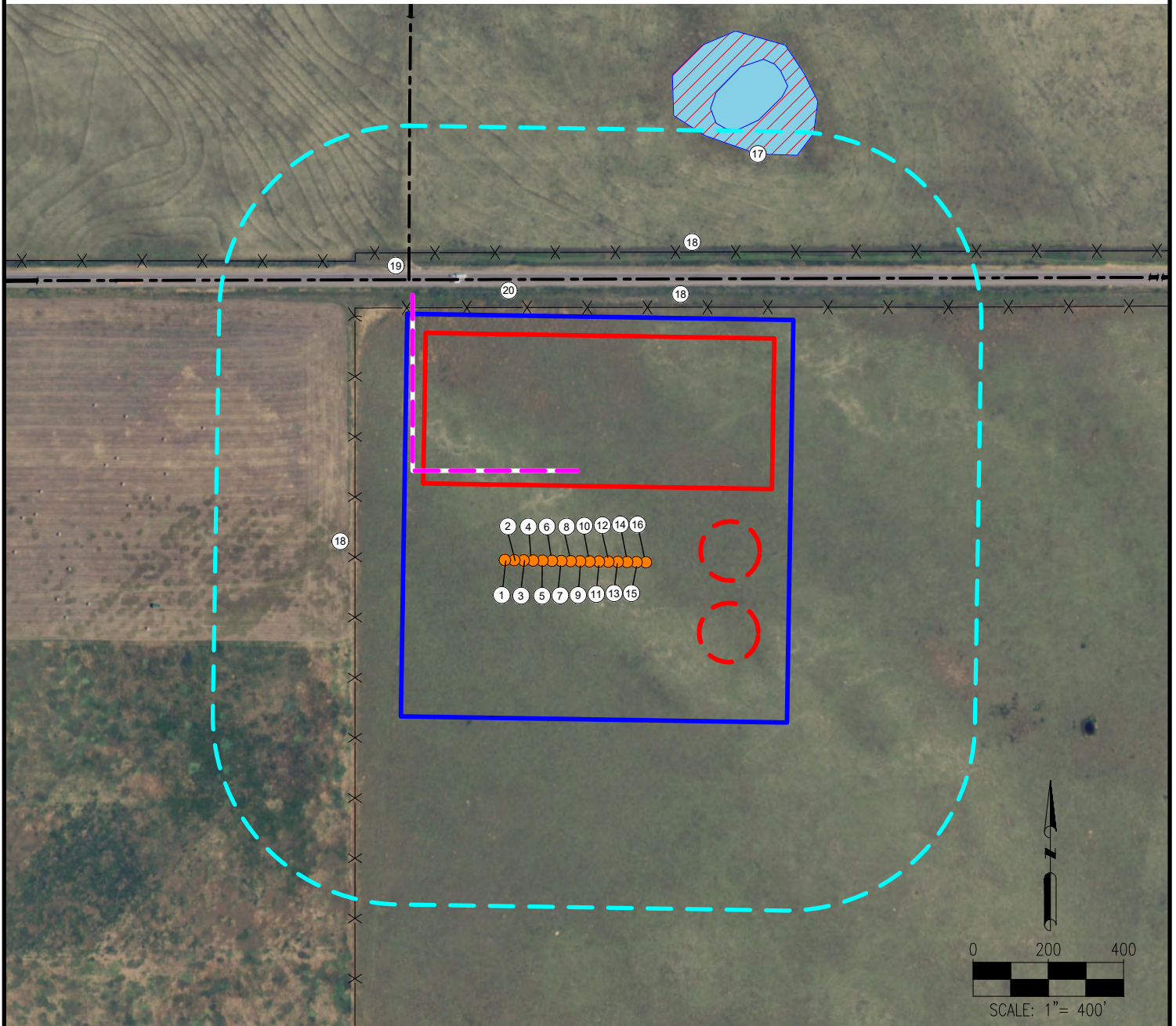


GADWALL PAD LOCATION DRAWING
