Inspection document was submitted on 12/11/2017 and has CA date of 12/12/2017. The Corrective Action fails to recognize that the final construction activities are ongoing at this location. The preliminary/pre-construction BMPs that have been installed provide perimeter controls and prevention of sediment runoff, including the areas

in the vicinity of the sediment traps. Implementation of Final BMPs will include adjustments to the existing Preliminary/pre-construction BMPs and the completion of inlet/outlet protection for sediment traps.

COGCC Decision: **Not Approved**

COGCC Representative: At this location, the BMPs should have been installed per good engineering practices at the time of the inspection. Sediment Traps are improperly installed. CA date was attainable; this was not a valid basis for review. BMPs installed prior to & during Construction must be effective and installed with Good Engineering Practices. Some errors in the COGCC data base delayed COGCC response to this FIRR.

COGCC Supervisor: At this location, the BMPs should have been installed per good engineering practices at the time of the inspection. Sediment Traps are improperly installed. CA date was attainable; this was not a valid basis for review. BMPs installed prior to & during Construction must be effective and installed with Good Engineering Practices. Some errors in the COGCC data base delayed COGCC response to this FIRR.
