## OPERATOR COMMENTS AND SUBMITTAL

Comments BBC requests to permit the BHL/TD for this well to be 400' FEL of Section 4. The ability to perforate will be physically constrained by the wet shoe sub and float collar which will be located no less than 460' FEL of Section 4. BBC will not perforate or complete the wellbore within the 460' setback area of the spacing unit. The distance to nearest completed portion of offset wellbore permitted or completed in the same formation is the Blackburn #01N-64W-08-8N (05-123-41049), which is approximately 437 ft away. This distance was measured in 2D. The distance from the proposed wellbore to the nearest existing or proposed wellbore belonging to another operator, including plugged wells is the Blackburn #01N-64W-08-8N (05-123-41049), which is approximately 437 feet away. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
