When he came to the wellsite on Monday (2/12/18) he noticed the bullet holes and he contacted Jim Javernick and Jim Javernick contacted the Sherriff. There are 2 holes (entry) on the E. side of tank and 2 holes (exit) on the W. side of tank. There are also several dings on the W. side of tank. The tank is 15 ft tall and the holes are at about 12 ft, so the was no spill. The tank was emptied on Dec. 28,2017, so the current level is 58 inches. There closest structure is 1/4 mile to the East.
