	<p>Surface disturbance areas from replugging operations performed by BBC do not meet Rule 1004 standards. The replugging surface disturbance areas (Burke location, an additional northern area, and access road) primarily consist of weedy, annual vegetation (Kochia, Russian thistle and cheatgrass) which is not reflective of reference area vegetation. Reference area vegetation consists of, but not limited to, Sand dropseed (<i>Sporobolus cryptandrus</i>), Sideoats grama (<i>Bouteloua curtipendula</i>), and Blue grama (<i>Bouteloua gracilis</i>). Refer to the attached inspection photos for more detail.</p>	
<p>Corrective Action:</p>	<p>Perform reclamation activities in accordance to COGCC 1004 reclamation rules and requirements to bring this location into compliance. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards.
