Comment Location's disturbance area partially within cropland on the southern end, and range land on the northern half. Areas not reasonable needed for production appear to have been reduced. Rig release date 8/20/2016, doc. #401081813 states IR to commence 1/15/2017. 1003.b requires disturbed areas to be reclaimed to their designated final land use no later than three months on crop land or six months on non-cropland. Based on observations, It does not appear as though cropland was returned back to agricultural activities, and revegetation activities do not appear to have been conducted on the interim areas within rangeland in 2017. Interim reclamation and revegetation activities in accordance to 1003 should have been conducted by 3/20/2017.

Corrective Action Perform interim reclamation in accordance to 1003, including but not limited to, revegetation activities (on non-croplands) on areas not reasonably needed for production. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage location. To take advantage of the spring growing season, revegetation activities shall be completed by 3/31/2018
